## ARTIFICIAL INTELLIGENCE AND DIGITAL RECORDS MANAGEMENT

Members of the DLM Forum gather for a two-day meeting twice a year in spring and autumn. At the meetings, we exchange current experiences and potential ideas of establishing comprehensive information governance over digital records and data. Additionally these meetings give valuable networking opportunities.

The DLM Forum is now calling for the submission of proposals for the next Annual General Meeting that will be hosted by the Croatian State Archives in Zagreb.

### The aim and topics

The aim of the meeting in Zagreb is to bring together all those in our community who are active and interested on topics in the field of artificial intelligence (AI) and its potential for digital records

management. We welcome a wide-range of papers including critical reflections that deal with AI and its scope to digital records management.

Possible topics for presentations include, but are not limited to:

- Al concepts, development and recent trends that can apply to digital records management
- possibilities that AI brings to the archives and heritage domain in general
- presentations of projects, approaches and results of AI usage in digital records management
- ethical issues and regulatory challenges raised by AI

If you or your organization has something exciting to share, please feel free to suggest a paper even if it does not correspond to the one of the above-mentioned topics.

#### Submission

Please send an extended abstract of **no more than 800 words** and a short biography of the author(s) of no more than **100 words** (presenters only) in a single Word document to <u>secretariat@dlmforum.eu</u> by Friday **20 March 2020**.

Applicants will be notofied of the outcome at the end of March.

#### **Extended** abstract

Extended abstracts are brief reports on current events or ongoing projects in one of the conference subject areas. The DLM Forum will schedule a maximum of 25 minutes for each presentation, which includes both lecture time and discussion.

#### **General guidelines**

The extended abstract shall be written in the font Arial (1.5 line spacing and 12-font size) and contain a maximum of 800 words. It should present (1) the scope of your work, (2) a brief description of the methods and approaches, and (3) provide an overview of your main findings and conclusions.

We ask you to use the following MS Word template for your contribution: Abstract Form.
